- **Before Installation:** Please email ICL&P a copy of vendor proposal/quote to obtain Pre-Approval of rebate funding. ICL&P will confirm **NOTICE TO PROCEED**.

- **After Installation:** Submit all final rebate documents to utility to begin final processing
 - Upon receipt of all rebate documents, Idaho County Light & Power (ICL&P) reserves the right to inspect home to validate energy efficient upgrades were installed according to program specifications.
 - Rebate(s) will not exceed 50% of the installed job cost. Rebate(s) for self-installed energy-efficiency upgrades will not exceed 50% of the cost of materials.
