- *MANUFACTURED HOMES MUST BE ELECTRICALLY HEATED, NEW, AND BE DESIGNED, CONSTRUCTED AND CERTIFIED BY THE NORTHWEST ENERGY EFFICIENT MANUFACTURED (NEEM) HOMES PROGRAM AS ENERGY STAR. THIS INCLUDES ECO-RATED HOMES.*
- *REPLACEMENT MANUFACTURED HOME MUST HAVE BEEN BUILT PRIOR TO 1976, BE ELECTRICALLY HEATED, AND OCCUPIED AS A RESIDENCE. THE EXISTING PRE-1976 HOME MUST BE DECOMMISSIONED AND DISPOSED OF AND CANNOT BE USED AS A DWELLING ONCE THE NEW NEEM HOME IS SITED.*
